APPLETON CITY COUNCIL REGULAR MEETING MINUTES WEDNESDAY, FEBRUARY 28, 2024

Pursuant to due call and notice thereof, a public hearing for the Schlieman Avenue Underground Utility Project was held on Wednesday, February 28th, 2024 in the Old Library Meeting Room at the Appleton Civic Center.

Mayor Koepp opened the public hearing at 5:30 p.m.

- I. Bob Schlieman from APEX Engineering gave a presentation that highlighted the project area, project needs, proposed improvements, estimated project cost, project financing/assessment methodologies, estimated cost sharing, estimated assessment terms, funding and estimated project schedule.
 - a. Estimated Project Cost: \$3,877,400.00 includes total project bid and engineering costs both for the project and for the Rooney & Behl improvements that were previously planned
 - b. Project Financing/Assessment : Each parcel that benefits from the project, which means that the property is served from a water service on Schlieman Avenue, will be assessed \$6,00.00.
 - c. Cost Sharing: Assessments will pay for \$366,000.00/9.4% of the project. The remaining \$3,511,400.00/90.6% will be paid with city utility rates and loans and/or grants.
 - d. Assessment Terms: 15 or 29 year terms with 3%-5% interest. This is not set in stone and will be finalized once all funding sources have been accounted for.
 - e. Anticipated Project Schedule:
 - i. March 2024 Award Contract
 - ii. Summer 2024 to Summer 2025 Construction
 - 1. October 2024 Substantial completion
 - 2. June 2025 Final completion with final lift of pavement
- II. At the conclusion of the presentation, residents and council were given a chance to ask questions about the project.
- III. Adjournment: A motion to close the public hearing and adjourn the meeting was made by councilmember Lhotka-Meyer and seconded by councilmember Enke. After a call for discussion and hearing none, Mayor Koepp called for a vote. All voted in favor and the motion passed. Meeting was adjourned 6:42 p.m.
